

Personality in science (bibliographic essay)



Vasily Trubnikov

Doctor of Law, Professor,
director of criminal-law disciplines
department, the assistant of the dean of law

Vasily Trubnikov was born on March, 12., 1942 in the village Voroninzi Orzhitskii area, Poltava region. He graduated from Kharkov Law Institute (nowadays Iaroslav the Wise National Law Academy of Ukraine) in 1969. Since then he held different positions in this high school: the worker of education-auxiliary laboratory of criminal law department, the postgraduate student, the assistant, the senior lecturer, of the associate professor, the associate professor of criminology and correctional-labour law department, the assistant of the dean, since 1987 - the dean of judicial - prosecutor's faculty № 1 (the present Institute on staff training for Prosecutor General's Office of Ukraine), since 1988 – director of of criminology and correctional-labour law department, since 1994 - the professor criminology and criminal - executive law department, since 2001 - the professor of criminal law and criminology department, the leading scientist of National university of internal affairs.

In 2003 V. Trubnikov was given a post of the director of criminal - law disciplines department of the law faculty of Karazin Kharkov National University. In 2004 he became the assistant of the dean of law faculty on scientific work, and also a chairman of the commission of legality and rules of the Academic council of Karazin Kharkov National University.

In 1995-2000 Trubnikov had an off-hour job as director of the sector of criminal - executive law of the Research institute on studying the reasons of criminality of the Ukrainian Academy of law sciences.

Except for it he was also a member of the Academic council of Iaroslav the Wise National Law Academy of Ukraine, scientific - methodical council of the academy, scientific - methodical council at the Ministry of Internal Affairs of Ukraine, regional organization «Knowledge» since 1969, Kharkov supervisory commission since 1970.

Vasiliy Trubnikov took part in the work of XI congress of the Union of Lawyers of Ukraine as the delegate from the Union of Lawyers of the Kharkov region. Has acted as the honourable founder of the Kharkov regional charitable anticancer Fund. He took part in the work of Working group of inter-parliamentary Assembly of the states - participants of the CIS (Saint Petersburg). Trubnikov was selected as a member of the local electoral commission, the chairman of the district electoral commission. In 2008 he studied at the state institute "Education-methodical center of civil protection and safety of life in Kharkov region" in Kharkov. After studying he received the certificate about the functional training in the field of civil protection (01.02.2008, registration № 82).

V.Trubnikov is the vice-president Penitentiary Community of Ukraine, the chairman of the coordination bureau on the problems of criminal - executive law of the Academy of law sciences of Ukraine, a private member of the international nongovernmental organization "Penal Reform International".

In 1975 he defended the dissertation, the theme of which was «the Criminal liability for violation of the rules of administrative supervision» on a speciality № 12.00.08 - criminal law and process. The academic status of the associate professor Trubnikov received on May, 23. 1979 on the criminology and corrective-labour law department.

In 1991 Vasiliy Trubnikov defended the doctoral dissertation on a theme: «Social adaptation of the released from punishment (legal and social - psychological analysis)» (speciality 12.00.08 - criminal law and criminology; criminal - executive law. According to the decision of the State committee of the USSR on national education on January, 29. 1992 № 8 Trubnikov became an academic status of the professor on the faculty of criminology and corrective-labour law.

Vasiliy Trubnikov is the author of more than 200 scientific works, 8 manuals, 5 textbooks on criminal - executive law of Ukraine.

The basic scientific works: «the Prevention of plunders of the state and public property» (1988, co-authorship), «Social adaptation of the released from the punishment», «the Mechanism of social adaptation of released from punishment» (both - 1990), «Criminal - executive law of Ukraine. General part», «Criminal - executive legislation of Ukraine. The collection of statutory acts», «Scientific - practical comment to the Law of Ukraine «About administrative supervision of the persons released from the places of imprisonment»» (all three - 1998), «Criminal - executive law of Ukraine », «Criminal - executive law of Ukraine. General part» (both - 1999), «Criminal - executive law of Ukraine. General and special parts» (2000), «Criminal - executive law of Ukraine» (2001), «General theory of social adaptation of the released from punishment (legal and social - psychological analysis of criminal - executive policy on rehabilitation of the condemned)», «Problems of social adaptation of the minors released from educational-labour colonies» (2003). (Last five works - co-authorship).

Scientific direction – the problems of criminal and criminal - executive law, criminology. He investigates the problems of social adaptation of the released from the punishment, the assignment and serving of criminal punishment. Vasiliy Trubnikov created the scientific school of the criminal - executive law of Ukraine.

He is the author of the bill, which was put by Verkhovna Rada of Ukraine as a basis at the passing of the new Criminal - executive code of Ukraine of 2003.

Carrying out the fruitful scientific activity Vasiliy Trubnikov is the member of two specialized academic councils (on the defence of doctoral dissertations – Д 64.700.01 and candidates' dissertations - К 64.700.03) in National university of internal affairs (Kharkov).

V. Trubnikov is the vice-president of the edition «the Bulletin of the Karazin Kharkov national university, section «Law»»; and he is also a part of editorial boards of the following professional editions: «the Bulletin of National university of internal affairs», «the Right and Safety», research-and-production magazine «State and Regions», scientific edition of the State research institute of the Ministry of Internal Affairs of Ukraine «Science and Law Enforcement».

Vasiliy Trubnikov trained 12 candidates of law sciences and is continuing to work on the training of the scientific and pedagogical staff, acts as the scientific adviser of ten post-graduate students and two doctoral candidates.

V. Trubnikov is awarded: by the anniversary medal «Twenty years of the Victory over Great Patriotic War of 1941-1945»; by the mark of the Ministry of Internal Affairs of the USSR «For excellent service in the Ministry of Internal Affairs»; by the medal «the Veteran of work»; by the Certificate of the Ministry of Internal Affairs of Ukraine «For the conscientious attitude to the duties, significant contribution to the perfection of teaching and educational process and to the commemoration of the 10th anniversary of Independence of Ukraine» on August, 24. 2001; by the Certificate of honour of the Ministry of Internal Affairs of Ukraine «For the conscientious attitude to the duties and significant contribution to the perfection of teaching and educational process and to the commemoration of the 10th anniversary of police of Ukraine» on December, 20. 2001; by the breastplate «For distinction in work» of the II degree by the order of the rector of National university of internal affairs on February, 7. 2002 № 128; by the letter of National university of internal affairs «For fruitful researches, high professional level, active participation in scientific life of National university of internal affairs and on the occasion of the Day of science in Ukraine» on May, 16. 2002 (the order № 692 on 12.05.2002); by the letter of Karazin Kharkov National University «For diligent fruitful work and active participation in restoration of the law faculty of Karazin Kharkov national university » on November, 19. 2004; by the mark of the Minister of Education and Science of Ukraine «For scientific achievements» (the certificate № 23 from January, 20. 2005, the order № 54); by the Certificate of honour executive committee of Kharkov council of Kharkov region «For faultless and fruitful work, high professionalism and on the occasion of professional holiday - Day of the lawyer» on October, 6. 2006 № 04059243.
